

## Washington, D.C. Legislative Update

Senator Hirono continues to fight to improve veterans' access to health care and benefits services. Her <u>new legislation</u> would improve access to emergency care, simplify the process to receive veteran survivors' benefits, and change Veterans Health Administration practices to increase the hiring of emergency physicians.

National veterans and medical groups praised Senator Hirono's new legislation, which you can read more about <u>here</u>.

"The VFW supports all three of these important measures which we believe will improve access

to care for veterans and timeliness of claim decisions for their survivors, and we thank Senator Hirono for her leadership in bringing them forward," said Raymond Kelley, VFW National Legislative Director.

"Senator Hirono's legislation will improve access to emergency care for our nation's veteran's by making the Veterans Health Administration more competitive with the private sector," **said Dr. Michael Gerardi, president of the American College of Emergency Physicians**. "Current VHA rules do not provide enough flexibility to recruit and retain the most qualified emergency physicians. My colleagues and I are honored about this potential opportunity to serve veterans."

VA Choice Card Customer Contact Center Opening Coming to Hawaii – TriWest Health Care Alliance, the VA's contractor for the VA Choice Card Program is in the process of opening a Hawaii Office that will include a customer contact center with more than 50 full time staff. TriWest has also established a team to work directly and collaboratively with the VA Pacific Islands Health Care System and our civilian network health care providers to help ensure timely access to quality care for Veterans. ### **Program Highlight of the Month**

Each month, our team highlights a VA benefit and shares local contacts that can provide you with more information about eligibility and enrollment. This month's program highlight is:

#### **Caregiver Services**

You may know that VA provides benefits and services for Veterans, but did you know that VA also has a number of services designed specifically to those who serve as a Family Caregiver? Family Caregivers provide crucial support in caring for Veterans. VA recognizes that Family Caregivers in a home environment can enhance the health and well-being of Veterans under VA care.

#### Services for Family Caregivers of Post-9/11 Veterans

Under the "Caregivers and Veterans Omnibus Health Services Act of 2010," additional VA services are now available to seriously injured post-9/11 Veterans and their Family Caregivers through a new program of Comprehensive Assistance for Family Caregivers. VA is now accepting applications for these services.

The application enables Veterans to designate one primary Family Caregiver and up to two secondary Family Caregivers, if desired. Caregiver Support Coordinators are available at every VA Medical Center to assist Veterans and their Family Caregivers with the application process.

#### Who Is Eligible?

- Veterans eligible for this program are those who sustained a serious injury including traumatic brain injury, psychological trauma or other mental disorder – incurred or aggravated in the line of duty, on or after September 11, 2001.
- Veterans eligible for this program must also be in need of personal care services because
  of an inability to perform one or more activities of daily living and/or need supervision or
  protection based on symptoms or residuals of neurological impairment or injury.
- To be eligible for the Program of Comprehensive Assistance for Family Caregivers, Veterans must first be enrolled for VA health services, if not enrolled previously.

#### Services Available to Family Caregivers through this Program

The law will provide additional assistance to primary Family Caregivers of eligible post-9/11 Veterans and Servicemembers. Services for this group include:

- · Monthly stipend
- Travel expenses (including lodging and per diem while accompanying Veterans undergoing care)
- Access to health care insurance (if the Caregiver is not already entitled to care or services under a health care plan)
- Mental health services and counseling
- Comprehensive VA Caregiver training provided by Easter Seals
- Respite care (not less than 30 days per year)

Please note that Members of Congress cannot request that the agency provide you with anything that is not authorized by federal law or regulation, or pressure the agency for particular outcomes. My office can request, for example, that you are afforded due process, that you
