# **Background Information:**

On Wednesday, March 6, 2019, Argosy University announced its possible closure. The announcement came after the U.S. Department of Education (USDOE) and the WASC Senior College and University Commission (WSCUC), Argosy's accreditor, took action against the institution. Current students and students who recently attended Argosy University, Hawaii are encouraged to attend transfer fairs to learn more about their options to continue their education elsewhere.

## **U.S.** Department of Education (USDOE):

The U.S. Department of Education (USDOE) has updated its Federal Student Aid website (https://studentaid.ed.gov/sa/) with more information related to Argosy University at https://studentaid.ed.gov/sa/about/announcements/dream-center. Students who are owed credit balance refunds should contact USDOE online at https://studentaid.gov/feedback or at 844-651-0077. Relief options for students may include transferring credits earned at Argosy to other institutions with a comparable program, or completing teach-outs at other institutions. Students are encouraged to use USDOE's College Scorecard at collegescorecard.ed.gov to research their options and select schools that meet their educational needs.

Should Argosy close, USDOE will assist students by posting information at https://studentaid.gov/closures, including a closed school fact sheet, a schedule of webinars, and information to contact state agencies. USDOE will also email students to make them aware of the resources and information available to them, as well as their options to continue their education or apply for a closed school loan discharge.

### U.S. Department of Veterans Affairs (VA):

The U.S. Department of Veterans Affairs (VA) has informed HPEAP that student veterans should continue to receive their housing stipends for as long as Argosy University is open and holding classes, and students are attending classes.
